





Young Film Network (South East) Application Form - Training and Development Bursary Fund

What is a Bursary? A 'bursary' is the term we use when we pay for something specific to help you develop in your film career. It could be for travel to a UK film festival to network with other filmmakers, tickets to an industry event or participation fee for a training course or workshop.

What's the aim of the Bursaries we provide? To encourage a greater awareness of routes into the film industry and increased knowledge and access to the industry.

Activity Supported: We will support participation in activity that will increase awareness and knowledge of the film industry. This could include but is not limited to:

- UK Film Festivals
- ICO Screening Days
- Field trips and local/regional networking
- Other industry opportunities and/or masterclasses identified by you or the young people you are working with.

We cannot support applications to attend international film festivals, higher or further education courses. Only economy/standard class travel costs will be eligible for support. Applications cannot exceed £350.

Assessment criteria

We aim to offer funding wherever it is financially possible, but not all applications will be successful. In our assessment of your application, we will consider:

- That you or the person(s) you are applying for are between the ages of 16-25 living in the Film Hub South East region (map of eligible areas here)
- Demonstration of case for financial support;
- Demonstration of commitment to the screen industries, and whether you are working full time, volunteering in or hoping to work full time, in the screen industries in the near future
- Any barriers you or the person(s) you are applying for may face to access or inclusion in the industry, or in your specific role or grade, for example because of where you live or because you are part of an under-represented group
- Impact of the proposed activity on professional development
